Immigrants currently have no right to a court-appointed attorney in the deportation process, so they must pay private attorneys or find a nonprofit organizations to help them. This is one reason why the Legal Defense Fund is so important and I support it. Immigrants also need to feel comfortable accessing the justice system. We don't want victims of crime to fear coming to court to testify or seek a protection order. When immigrants can't or are afraid to access our justice system, it makes our entire community unsafe. Denver has taken some important steps in the right direction in this regard, such as the Public Safety Enforcement Priorities Act.

I would support initiatives that encourage and assist with integration such as job training and language classes. In my administration, Office of Economic Development (OED) will take a more active role supporting refugee and immigrant small businesses.

8. Barriers to childcare, affordable housing, and transportation can be amplified in communities of color and communities where English is a second language. How do you propose to ensure equal access to these vital family supports? *

Childcare and housing costs are too high for many of our residents, and the lack of attainable housing has reached crisis levels. My plan for housing includes, increasing housing inventory by buying back units before they go to market rate and keeping them affordable and building affordable housing where it's needed most especially in historically marginalized communities. If we are to be a city for every generation and all of Denver's diverse communities, it's critical that we elevate attainable housing oversight and action to the highest level within the City of Denver. I will hold myself and my administration accountable to turn allocated funding into actual housing. I support implementing a network of transit and supportive mobility that is affordable and moves people to where they want to go. I support RTD eliminating fares for youth 18 and younger and support increased funding for pedestrian improvements to ensure safe first and last mile connections to transit.
